Stephen William: Over my career I've tried dozens and dozens of cases and we've been pleased to

achieve many plaintiffs verdicts where the awards by the jury have been in the

million dollar range and the multimillion dollar range.

Whoever you choose as your lawyer, that's not just your advocate with the insurance companies, it's not just your advocate, ultimately, in the court room,

this is your partner, your guide, through what can be a long road.

Maribel M.: My goal was going back to my normal life. It was very difficult.

Stephen William: After several decades of working with folks who suffer injuries you begin to

understand, even though you're not living it yourself, in a very visceral way,

what is impacting them.

Oscar G.: My life is going to be different from now. You cannot go with your kids to play

anymore. It change your life. I think I did the right thing getting an attorney.

Elaine C.: This was shocking. When you're driving you don't expect that, and it's the route

you take every morning. Oh God. It's like my world turned over.

Stephen William: When we have folks who come to us following such an incident, there's usually

a mix of confusion, anxiety, and then the physical manifestations of the injury.

Any one of those things taken alone can be overwhelming. When it's all of it all

at once, it's hard for people.

Maribel M.: He did everything to make me feel confident.

Stephen William: The insurance companies are big and their MO is to defend these cases,

regardless of the underlying merit of the claim. Regardless of what the evidence may show. They hire teams of lawyers to defend these cases. Lawyers who do

these cases almost exclusively and have tremendous experience.

Daniel P: They wanted to paint a picture that I wasn't a good guy.

Stephen William: You 100% need a lawyer who does this kind of work all the time, has been doing

it a long time, and has substantial experience standing up for injured folks

fighting insurance companies and winning.

Oscar G.: He's a tough guy. Every time he got a meeting with the other lawyers he would

come, say this is what they do, and they offer this. He'd say, we're not going for

that. He really knows what he's doing.

Stephen William: These settlements are final and that's why it's so important to have a good

lawyer to make sure that whatever that resolution is, it's covering the full scope of the injury and the injuries implications. Not just up to now when the case resolves, but into the future for the rest of the person's life because most often

these are permanent injuries with permanent effects on the person's ability to

do their activities and ability to work.

Daniel P: My life, I think, is better, the day I met Steve. He was actually there in the

trenches and he actually viewed me as a person.

Oscar G.: I was really relieved. We're really happy. Right now we'll go on vacation with the

kids. I feel really great. We're not struggling anymore.

Maribel M.: We sat down and she told me the amount, I was like, oh my God. Like a dream.

Elaine C.: I have no words to explain how awesome Steve is, and I wish for anybody with

kids, I want them to be the lawyer like Steve.
